Clean the glass thoroughly, measure and cut the film to size, then apply it using a slip solution and squeegee to remove bubbles. Ensure proper alignment and trim any excess film. Allow the film to cure for 24–72 hours for full adhesion and clarity. We recommend a Snapguard Solutions 4-piece window film installation kit available on snapguardsolutions.com.
